

On May and November, the Public Debt Program of CEMLA (PDP) elaborates and publishes a Macroeconomic Indicators bulletin for Latin America and the Caribbean (LAC) and LAC countries. These indicators are elaborated with data from the International Monetary Fund (IMF), the Inter-American Development Bank (IDB), and the Economic Commission for Latin America and the Caribbean (ECLAC). Likewise, the PDP elaborates indicators for post HIPC countries, which can be found in the PDP website.

In general, data and its respective charts reflect a deteriorating macroeconomic environment in the region between 2012 and 2015¹, period that can be denominated as bust period. The GDP growth rate of LAC has been declining since 2011, and in 2015 it was -0.03%. This environment, along with a deterioration of the current account, caused mainly by a diminishment in commodity prices, and government's overall

fiscal balances have generated an increment in public debt levels in the last years. The ratio public debt to GDP reached 55.6% at the end of 2015, which means an increment of almost 10 points of GDP if we compare it to the average of the period 2005-2011, 47.6%. According to the IMF, public debt levels above 40% of GDP increase the probability of a debt crisis between a 15% and 20%². Based on data from the World Economic Outlook (October 2016), 11 countries, such as Brazil, Colombia, Honduras, Jamaica, Nicaragua and Venezuela are above this limit.

The described macroeconomic environment, along with external risks, such as the uncertainty related to trade flows, a raise in interest rates, and the capital flows and exchange rate volatility are challenges that the region will face, regarding debt sustainability and funding strategy.

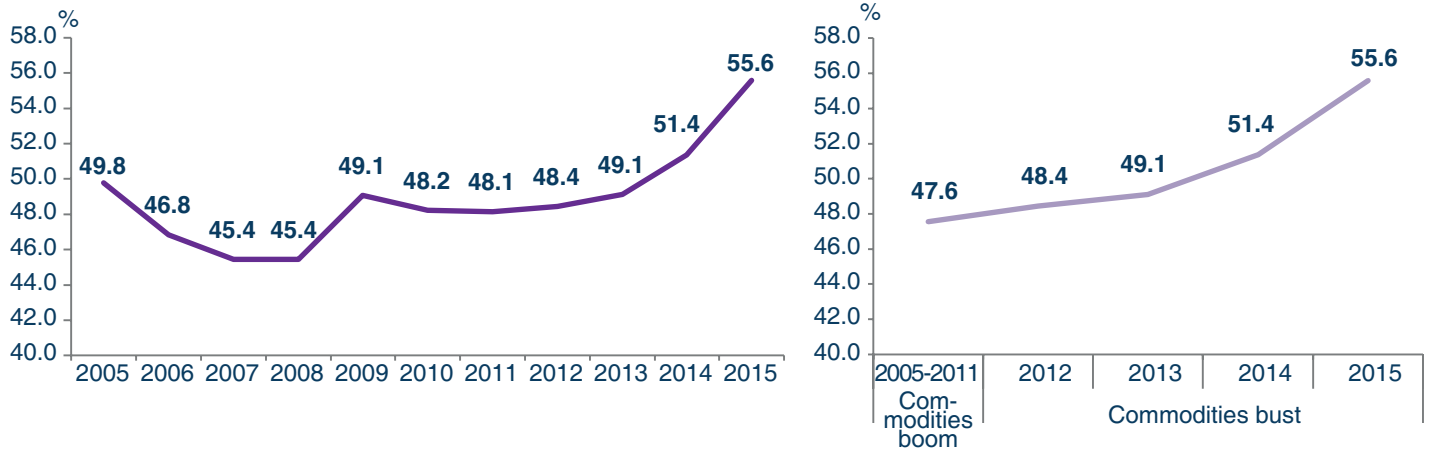
LAC: GROSS DOMESTIC PRODUCT



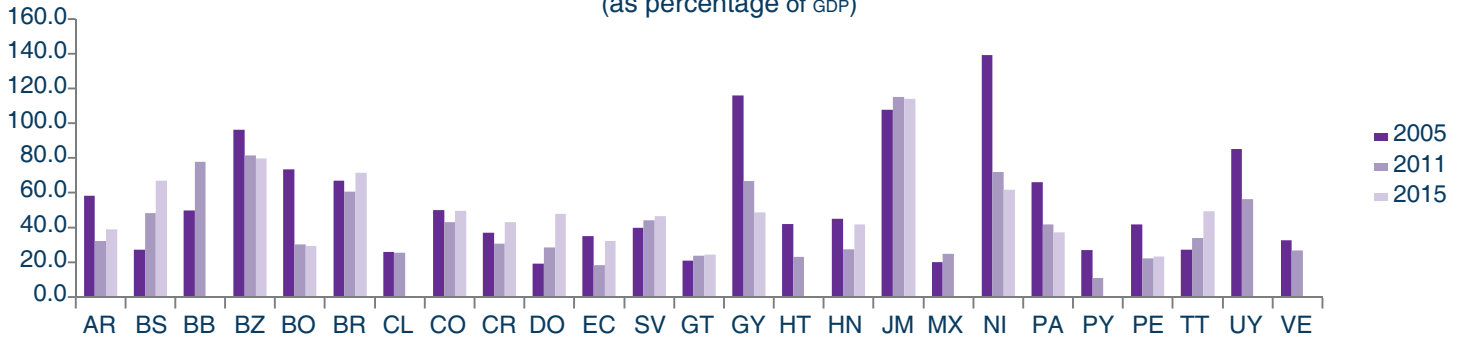

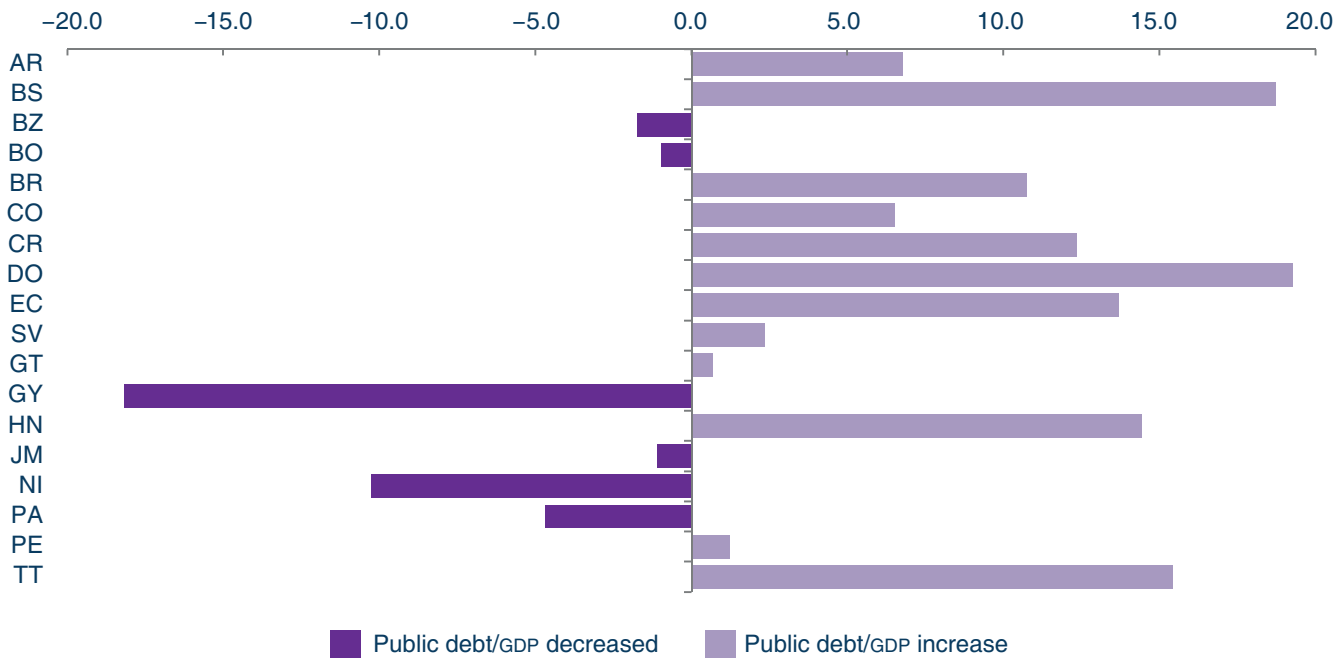
LAC: TOTAL PUBLIC DEBT

(as percentage of GDP)

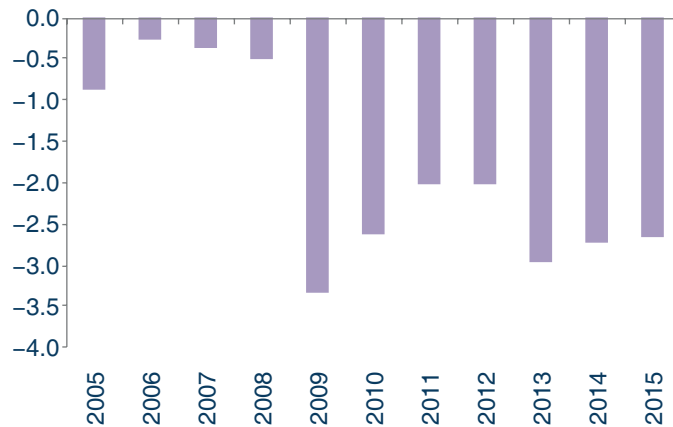


PUBLIC DEBT VARIATION AS A PERCENTAGE OF GDP
(2011-2015)

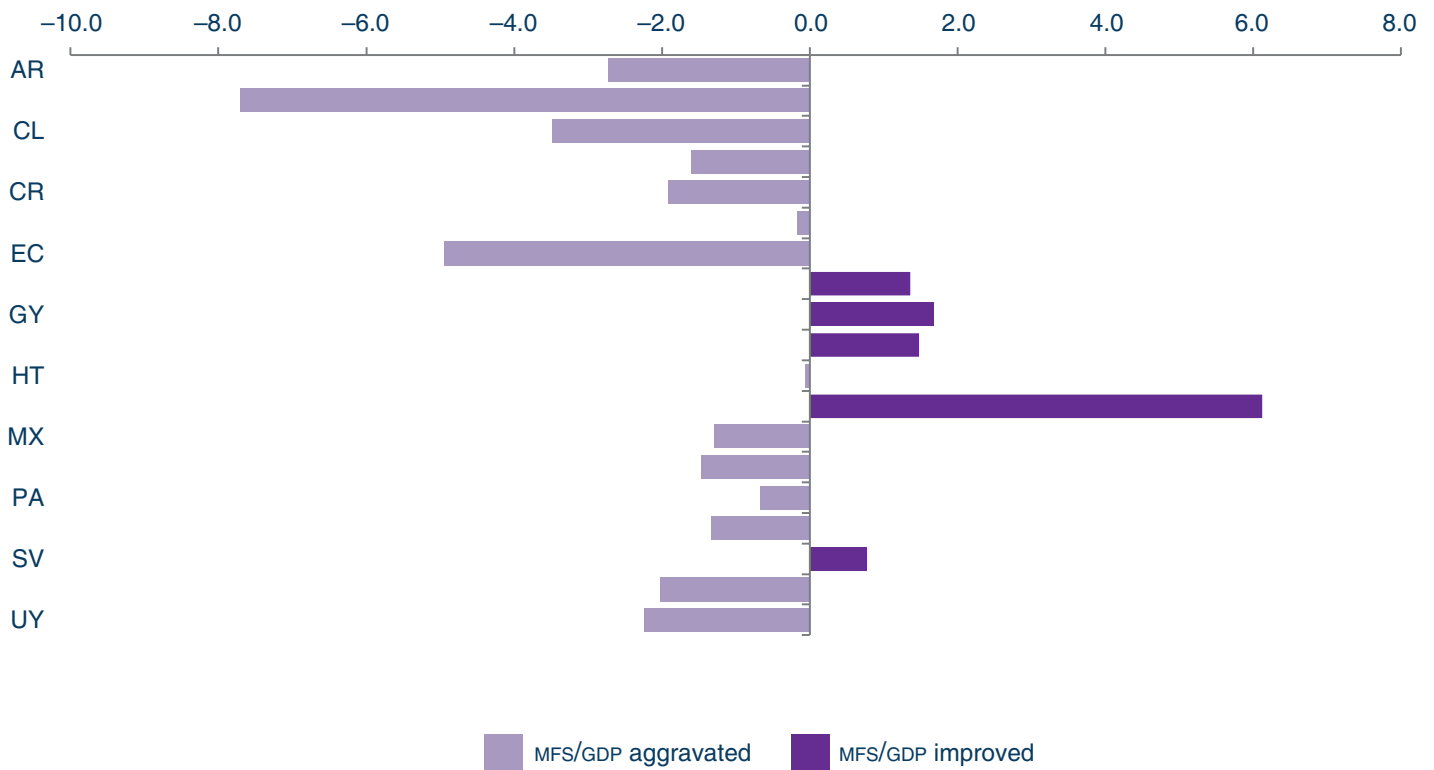

(as percentage of GDP)



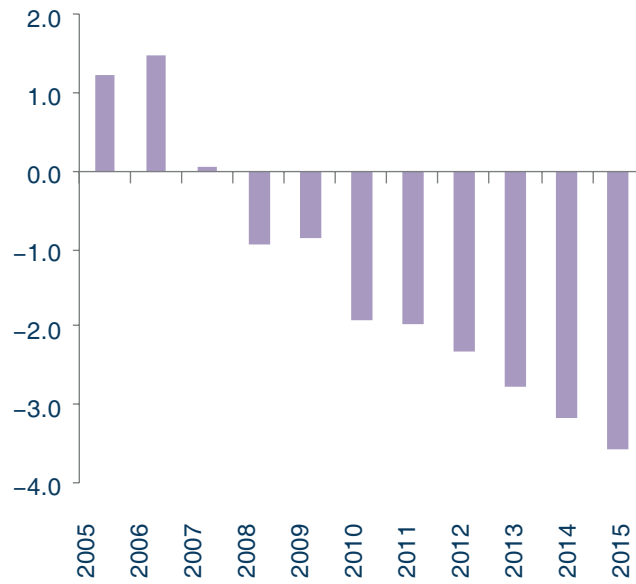
OVERALL FISCAL BALANCE VARIATION BETWEEN 2011 AND 2015
(as percentage of GDP)



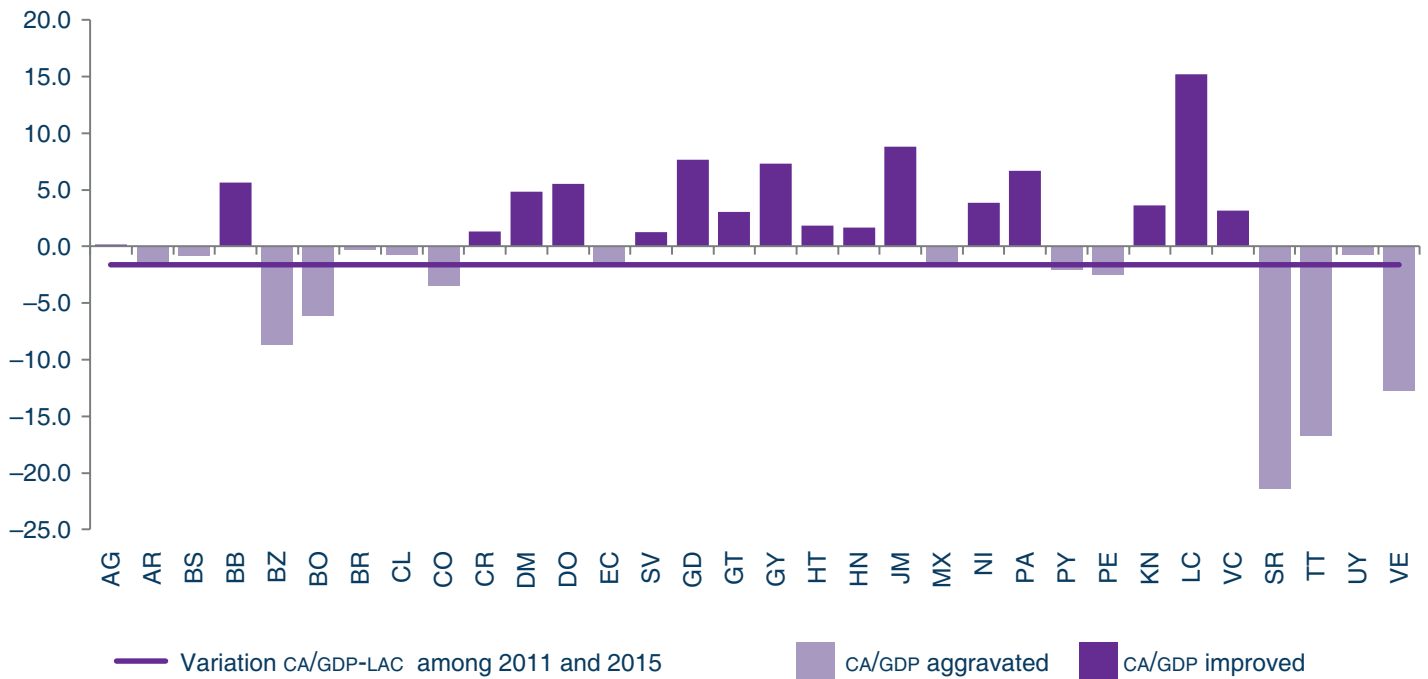
